Legislative Report Chair, Scott Holwell

Discussion: The 2021-2022 legislative session concluded on August 31, 2022. Our firm worked on behalf of CACVSO with the Newsom Administration and Legislature to help improve the quality of life for veterans and their families. During the 2022 legislative year, our firm worked on and monitored 90 military and veteran bills. A total of 24 of those bills were sent to the Governor, who had until September 30, 2022, to take action on all bills sent to his desk. He signed 22 of the 24 bills presented to him.

Reeb Government Relations also worked on and collaborated closely with several interested parties to obtain state funding (\$110,000) through the State Budget Act to restore the California Vietnam Veterans Memorial (CVVM) located in the State Capital Park. The budget was signed by the Governor on June 27, 2022. The money for CVVM is appropriated to the Department of General Services to conduct repairs and restoration of the memorial. On a somber note, long-time Veterans Advocate Pete Conaty passed away on July 31, 2022. Pete was involved from the beginning of planning for CVVM and was instrumental in securing its construction and celebrating key milestones. One of his final achievements was seeing that his fellow brothers and sisters in arms would continue to be honored and recognized through the restoration and maintenance of the memorial.

The state budget totals \$308 billion. Governor Newsom announced that \$50 million would be appropriated for the establishment of the <u>California Veterans Health Initiative (CVHI)</u>. The CVHI will deliver a comprehensive, coordinated statewide approach to ending veteran suicide by focusing on prevention, early intervention, and direct services to effectively combat the risk factors associated with suicidal ideation. Details on this initiative will be developed and released by CalVet.

SB 837 has been sent to the Governor for his signature. This bill removes the requirement for a payment to have the "VETERANS" designation. We have had many bills requiring the removal of the \$5 fee in front of the legislature. Over the past couple of years, this type of bill was delayed due to the legislature prioritizing and focusing on pandemic-related legislation. Effective 1/1/2023.

Barstow - No Memory Care, Admissions: 1-760-252-6200 (Crystal)

Site Visits – NO; Available units – Yes, priority is given to homeless veterans; Semi-Private rooms, so you could get a roommate.

Fresno- Admissions: - 1-559-493-4224; Site Visits – NO; However, they are allowing residence to have visits from family; Available units – NONE– Wait Lists for All Units; Assisted Living – 3-4 months; Skilled Nursing and Memory Care – 3-5 yrs.; Private Rooms-Double rooms for Married Individuals.

Redding - Admissions: 1-530-224-3800; Site Visits – Currently closed campus. They do have a virtual tour on you tube: Living at the Veterans Home of California – Redding - it's approx. 4 minutes in length; Available units – None currently; Residential Care – (independent living) 1-2 years, Skill Nursing – 6+ years; Memory Care - 3+ years; All Rooms are single occupancy with private bath.

West LA- Admissions: 424-832-8200 then press 4 (Windy or Diana x2); Site Visits – None currently; Available units – NONE; Assisted Living – Just open wing 60beds+ No wait list; Skilled Nursing and Memory Care (Always accepting any applications); Normal wait list is 2-3 years for both Skilled Nursing and Memory Care

Chula Vista - Admissions: 619-482-6010 press 4, then you must choose by alpha character either, 1 for A-L or 2 for M-Z; Site Visits - YES – You need to bring your vaccination card and if not vaccinated, a COVID NEG test within 48 hrs; Available units – NONE - All three Independent Living, Assisted Living and Skilled Nursing Care applicants are placed on a Wait List; Roommate situation

Lancaster – William J Pete Veterans Home; Admissions: 661-974-7035 then press 6 (Norma); Site Visits - Yes – you need to wear a mask. No vaccination required; Available units – Some availability, 30 day to move in-Wait List, normally 6 months); Roommate suite situation, common area and a share bath situation, but private bedroom (10x10) which has a hospital bed, TV and chair

Ventura- Admissions: 805-659-7500 then press 6, (Leana); Site Visits – YES. Vaccination card required, if not vaccinated you must bring your own test and they will test you prior to accessing the facility (these changes are ongoing for they are governed by CDV guidelines); Available units – No availability -- Normal wait list is approx. 6 months; Roommate situation: one big room with a divided floor to ceiling device and a curtain. They share a bathroom. Common area within the building which is utilized by all.

Yountville - Oldest and Largest Facility; Admissions: 707-944-4601 – Dick Sutton; Site Visits - Now suspend due to COVID; Available units – Independent – private rooms, however, communal bath facilities which are down the hall. They are getting people in NOW, since for two years they did not admit anyone and through

attrition they now how space. Assisted living – Private room and they too have available slots. Skilled, Assisted and Memory are Roommate situations, so they are on a paused due to COVID. They are working on the 2017 wait list. They are not taking anyone currently, due to various reasons to include COVID and Staffing issues.
