### Legislative Report Chair, Scott Holwell

Discussion: Jack Kirwan discussed VSOF is strictly for supporting CVSO's. Administration, training, and VetPro costs. Set number been appropriated for number of years, year-end balance 150,000 per year approaching 3 million dollars on June 30, 2021. Appropriate for one time uses. Proposing a bill to finance one-time costs all counties in setting up virtual office. Will run by CalVet for support. Fiscal year 2022-2023 would be affected by this bill. Revenue increase is being addressed as a Budget ask, meet, and confer committee must agree. Seth Reeb shared a worksheet showing district and capitol contact for each county. Assemblyman Norris strong inclination that she will carry budget ask. Deadline this Friday. Anticipating up to 2,000 bills by Friday. Will post on member section of website.

Jim Frazier is now joining us in zoom conference. Honor Assemblyman Jim Frazier with the Legislature of the Year award from our association. 2019 he undertook two-year process of DMV to accept certification from a VSO AB 408 signed into law 2020. 2015 veteran designation on Ca Driver License AB 235 authorized 3 bills in two-year period to make this happen. Thank you and Congratulations. Continues to be on Veterans Committee. Working on building relationship with CalVet director. Still wants to introduce Bill for a full property tax exemption for 100% service-connected veterans. Driver's License bill has changed thousands of veterans' lives.
