## CHALLENGES FACED BY IN-CUSTODY VETERANS

- MENTAL HEALTH CONCERNS AND PTSD TRIGGERS IN JAIL SETTINGS
- LACK OF ACCESS TO VETERAN-SPECIFIC SERVICES
- UNCERTAINTY OF CRIMINAL JUSTICE PROCEEDINGS, AWAY FROM FAMILY (PHONE CALLS), JAIL ENVIRONMENT NORMS
- CHALLENGES IN RECEIVING VA BENEFITS WHILE INCARCERATED






# WHAT WORKS - EFFECTIVE INTERVENTIONS

- VETERAN-SPECIFIC HOUSING UNITS IN JAIL
- EVIDENCE-BASED, COGNITIVE BEHAVIORAL, RESTORATIVE PRACTICES, CREATIVE ARTS, COMMUNITY SPEAKERS, TRAUMA RESPONSIVE CARE, AND HARM REDUCTION
- PEER MENTORSHIP SUPPORT



## WHAT WORKS - EFFECTIVE INTERVENTIONS - 2

- ACCESS TO MENTAL HEALTH TREATMENT AND TRAUMA-INFORMED CARE
- COLLABORATION WITH VETERAN SERVICE ORGANIZATIONS (VSOS) AND VA LIAISONS
- REENTRY PLANNING WITH VETERAN-FOCUSED SUPPORT NETWORKS
- KNOWLEDGE OF VETERAN AND COMMUNITY-BASED SERVICES


### MOVING FORWARD – STRATEGIES FOR IMPROVEMENT

- POLICY CHANGES TO STREAMLINE VA BENEFIT ACCESS WHILE INCARCERATED
- EXPANSION OF VETERAN TREATMENT COURTS

  AND DIVERSION PROGRAMS
- INCREASED FUNDING FOR TRANSITIONAL HOUSING, MENTAL HEALTH, AND SUBSTANCE ABUSE TREATMENT
- STRENGTHENING COMMUNITY PARTNERSHIPS FOR REENTRY SUCCESS
- TRAINING JAIL STAFF ON VETERAN-SPECIFIC ISSUES AND TRAUMA-INFORMED CARE

#### CALL TO ACTION

- ADVOCATING FOR BETTER POLICIES AND RESOURCES
- ENGAGING LOCAL, STATE, AND FEDERAL AGENCIES IN SOLUTIONS
- ENCOURAGING PUBLIC AND PRIVATE PARTNERSHIPS TO SUPPORT REINTEGRATION
- ENSURING CONTINUOUS RESEARCH AND DATA COLLECTION TO REFINE APPROACHES
- ACCESS VETERAN WITHIN 24 HOURS OF BOOKING
